#### **Summary Paragraph**

Wilford L. Coffey School occupies a full city block bounded by Gilchrist Avenue, Vassar Avenue, Lindsay Avenue, and Cambridge Avenue. It is located on Detroit's northwest side, about twelve miles northwest of downtown. While the northern half of the site is occupied by a parking lot and playfield, the school building is located on the southern half. It was constructed in 1925 as a small, single-story, four room school building. Although the original structure remains in more or less original condition, it was greatly expanded with a two-story addition built in 1956. The 1925 building is a modest, flat roofed brick structure with stone trim and a prominent, side-facing bay window. Its addition is similar to other Detroit school buildings designed in the 1950s, with continuous bands of glass block defining its otherwise brick-faced facades.

# **Narrative Description**

The original Coffey School building, facing west onto Lindsay Avenue, features a prominent main entry flanked by blind walls, and is windowed on its north and south elevations. Its floor plan places two rooms on either side of a central corridor. The building is clad in orange, common-bond brickwork. The only major alteration to the building's façade is its modern aluminum and glass entranceway, consisting of a pair of double doors flanked by wide sidelights and surmounted by a transom. The doorway is several stone steps above grade, set within a thick, stone, round arch, and surmounted by a square stone panel depicting an open book. The entrance section is framed by shallow, buttress-like piers. It projects outward several feet from the plane of the façade's remaining wall surface, which consists of blind walls highlighted by upper and lower stone belt courses and framed by additional buttress-like piers. The building's windows, located on its side elevations, are historic, hinged, multi-pane metal windows. A large, five-faceted bay window, trimmed in stone, projects from the buildings south elevation.

A two story, flat-roofed addition was constructed in 1956, extending to the east and wrapping around to the south and west to give the final building an overall U-shaped footprint. The resulting building features a principal façades on Cambridge Avenue to the south, with secondary entrances on Lindsay Avenue to the west and serving a gymnasium and auditorium on Gilchrist Avenue to the east. The building is clad in orange brown, common bond brickwork. Continuous fenestration extends across a majority of the wall area; classroom windows are glass block on their upper two-thirds, while the lower third consists of transparent glass in hinged aluminum frames. A single story boiler room with smokestack projects from the building's northern elevation.

Statement of Significance Summary Paragraph (provide a summary paragraph that includes level of significance and applicable criteria)

Wilford L. Coffey School is locally significant under National Register Criterion A as an example of a small, neighborhood school built by Redford Union Schools prior to the annexation of that part of Redford Township by Detroit in 1926. It is additionally significant under Criterion C as a single-story, small scale school building erected for an exurban community. Its much larger, modern style addition from 1956 reflects the later expansion of the Old Redford part of the City of Detroit.

Narrative Statement of Significance (provide at least one paragraph for each area of significance)

The four-room Coffey School opened in 1925 as an annex to Newton School. At the time, it was located within Redford Township and operated by Redford Union Schools. It was named for Wilford Larn Coffey, State Superintendent of Public Instruction, and later, Dean of the Detroit City College.

The Redford Union School district also built Mettetal and Hubert elementary schools in the same year. They are amongst several smaller schools built in the townships, still far from the city center. Although the architect of Coffey School is unknown, the school districts acted independently in their hiring of architects, adding more variety to the Detroit system once annexed.

Coffey School was operated by the Detroit Board of Education starting in 1926, when the area was annexed by the growing city. Still, the area immediately surrounding the school lagged behind somewhat in its development. Coffey School closed in 1933 but reopened in 1936, with one room serving grades 1-3 while the remaining rooms provided space for sewing and manual arts classes for students of surrounding schools.

In 1942, as the surrounding community began to grow more rapidly, all four rooms were used for kindergarten and grade school instruction. Portable buildings were added in 1945 and 1953 to respond to increasing enrollment. From 1954 to 1956, the upper grades of the school were moved to Larned, Monnier, and Bow schools while an addition could be built.

This new addition, completed in the spring of 1956, and added eleven classrooms, two social studies rooms, two science rooms, a conservatory, an art room, a homemaking room, an auditorium, and a combination gymnasium and lunchroom with kitchen. The cost of this unit was \$975.662, and it now allowed the school to accommodate 1,085 students. By September of 1956, however, school enrollment had reached 1,246. In 1957, a portable classroom building was moved to the site.
